



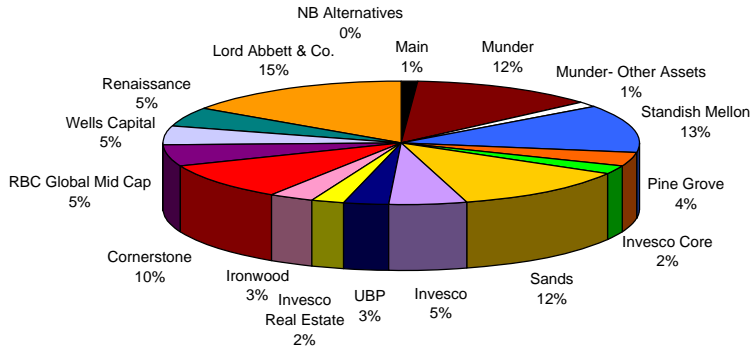

Retirement System Account Allocation



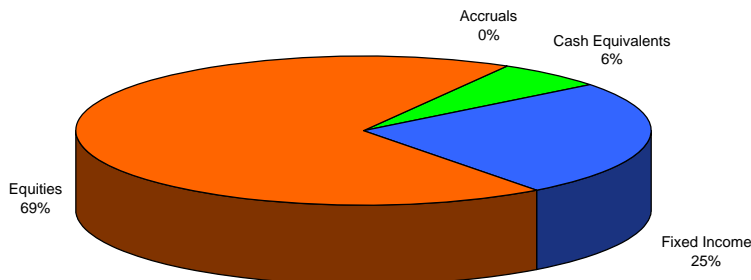

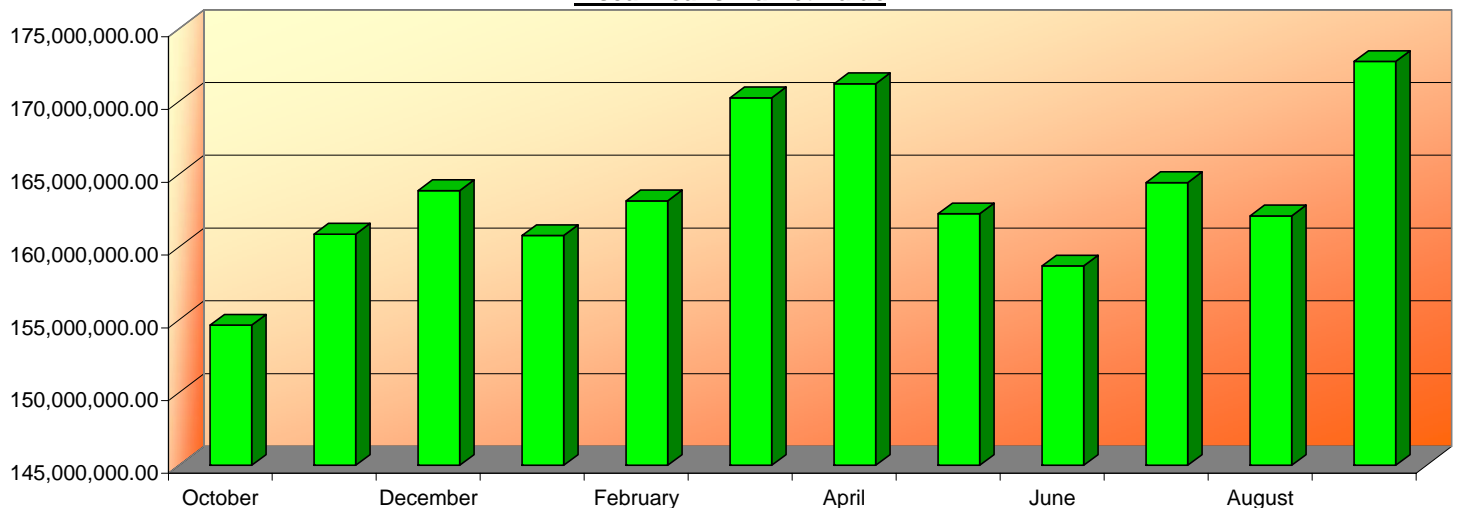

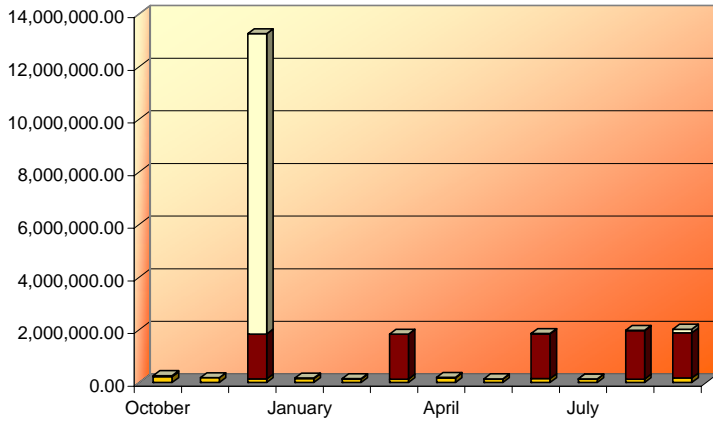

Fiscal Year's Market Value

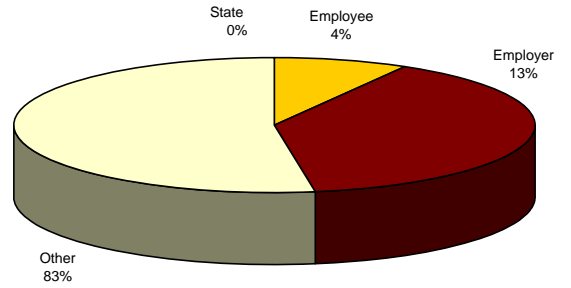

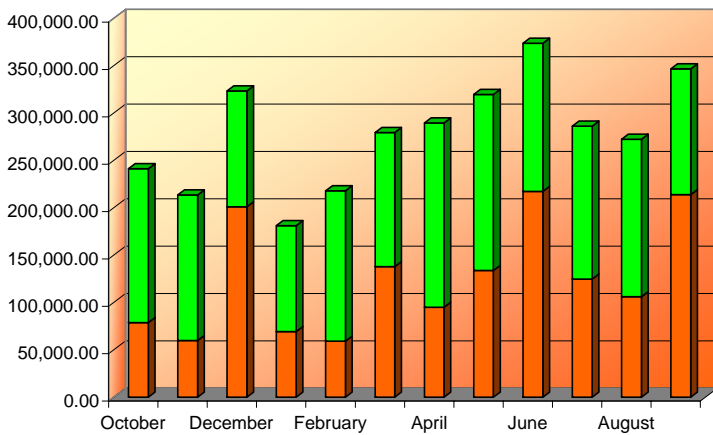
Fiscal Year's Contributions



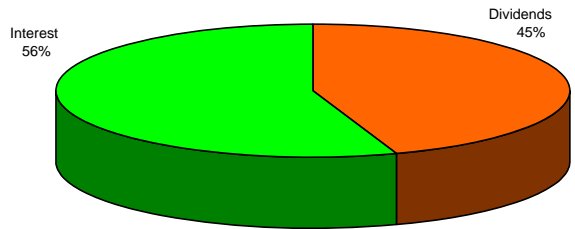
Contributions for the Fiscal Year



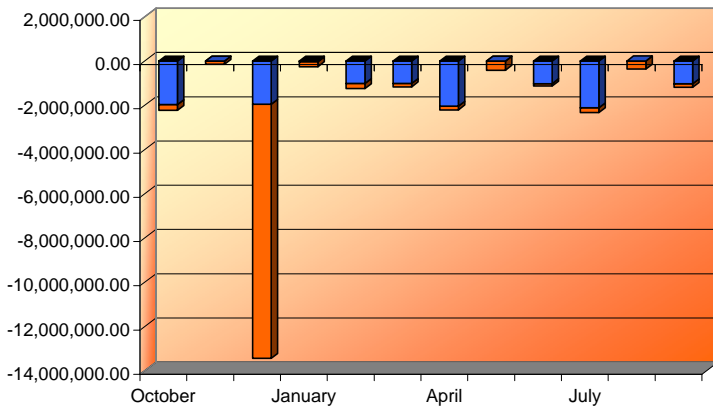
Fiscal Year's Income
