PRESENTATION OF OCTOBER 1, 2024 ACTUARIAL VALUATION BY NYHART					
Samantha Olson was in attendance via Zoom to present updates to the 10/1/2024 Actuarial Valuation after the Chairman, Mr. Watts and the Executive Director met with the City Manager and his staff to discuss tailwind volatility mitigation strategy. It was agreed upon by both parties to implement Nyhart's proposed strategy. There was no change to the assets or liabilities presented last month.					
The only change made is to consolidate the amortization bases from 10/1/1995 through 10/1/2001, and to amortize those bases over the next seven years. As a result, the recommended contribution for FY 2025-26 is approximately \$27.9 million, an increase of approximately \$4.4 million compared to the prior year, and an increase of approximately \$1 million from the last month's presentation.					
The strategy is to increase the employer contributions in the near-term, and as a result, the following contribution years will decrease and the Plan would see a saving of approximately \$1 million. By paying earlier, the amortization ends up costing less later on and with less volatile contributions over the next seven years.					
<ul> <li>Ms. Olson reviewed the results of the NCPERS Public Retirement Systems study which were not available last month when Nyhart made its presentation to the Board.</li> <li>The average funding level increased approximately 8% from 75.4% to 83.1%.</li> <li>The average return assumption was 6.67%.</li> <li>Amortization tightened from 20.4 years to 18.5 years</li> <li>59% of respondents utilize a closed amortization approach.</li> <li>Average expense (administration and investment) is 73 basis.</li> </ul>

However, you must disclose the nature of the conflict before making any attempt to influence the decision, whether orally or in writing and whether made by you or at your direction.
